As we celebrate the first anniversary of Green Key India, launched on August 8, 2023, in New Delhi, we proudly reflect on the significant strides made in advancing sustainable hospitality practices. Green Key, a global certification programme established by the Foundation for Environmental Education (FEE) in Copenhagen and implemented in India by the Centre for Environment Education (CEE), has been instrumental in promoting environmentally friendly operations within the hospitality sector.

Over the past year, 12 esteemed hotels have achieved certification, including Sofitel Mumbai BKC, Novotel Pune Nagar Road, Novotel Hyderabad Airport, Grand Mercure Mysore, ibis Bengaluru Outer Ring Road, Novotel Bengaluru Outer Ring Road, Mercure Hyderabad KCP, Novotel Guwahati, Novotel Mumbai International Airport, Pullman New Delhi Aerocity, Novotel New Delhi Aerocity, and Grand Mercure Bengaluru Gopalan Mall. Further, Grand Mercure Ahmedabad Gift City, ibis Gurgaon Golf Course Road, Novotel Goa Resorts and Spa, and Novotel Goa Candolim have undergone auditing.

With over 50 hotel applications received to date, Green Key India focuses on reducing carbon footprints, conserving water, managing food waste, improving biodiversity, and engaging in corporate social responsibility. During this year Green Key received enough support from the management of Accor hotels in India for its implementation. Additionally, the dynamic general managers of the hotels walked extra miles ensuring the translation of the Green Key criteria into practices within their hotels. Green Key has collaborations with other reputed international hotel chains like Radisson Hotel Group and InterContinental Hotels Group (IHG). Green Key India has also received applications from stand-alone hotels for certification.

Looking ahead, Green Key India plans to extend its certification to restaurants and campsites, further enhancing its commitment to sustainable practices across the hospitality industry in India.
