#### 1. Introduction

The Centre for Environment Education (CEE), funded by the HDFC Bank under the "Rural & Urban Landscape Free of Dry & Plastic Waste" project, invites qualified contractors to submit Quotation for the construction and erection with complete electrical work of the shed and other civil work at the **Material Recycling Centre** (MRC), Jammu. #### II. Financial Proposal:

- Detailed cost breakdown including labour, materials, equipment, and any other expenses.
- The rates quoted shall be in Indian Rupees and shall be inclusive of all taxes, duties, and levies as applicable up to the completion of the job.
- o Payment schedule aligned with project milestones.
- Any other terms or conditions (CEE may reserve the right to consider or not).

#### III. Qualifications and Experience:

- Company profile including papers and experience in the construction of at least one such shed or similar projects in the last 3 (three) years.
- Resume of key personnel involved in the project.

#### IV. Legal and Compliance:

- Compliance with local and national regulations.
- o Copy of registration certificate under income tax and GST (If applicable),
- Copy of last three years' income tax return,
- Copy of last two GST returns,

- Copy of address proof.
- **4. Duration**: The duration of said work in the attached Annexures shall be till 15<sup>th</sup> March 2025.
- **5. Payment Terms & Conditions**: The tentative payment schedule is as follows:
  - i. CEE shall, upon a written request by the Vendor, allow maximum 40 % of the total Contract amount, after start of work, submission of work plan & material arrival & verified by CEE consultant/ official (architect/engineer).
  - ii. The vendor may submit a request for payment to be paid by Centre on completion of civil work up to the walls of the shed and foundation work and starting erection of the MS poles and fabrication of trusses for roof, and we may allow 40% of the total Contract amount and certification of work done by Centre's consultant/ official (architect/engineer).
- iii. Progress payment (remaining 20%) shall be adjusted by deducting the amount in Final Bill payment.

#### 6. Evaluation Criteria

Proposals will be evaluated based on the following criteria:

- Technical expertise and experience in similar projects.
- Quality of the proposed project plan in the timelines.
- Compliance with the provided design and BOQ.
- Cost-effectiveness and financial feasibility.
- · References and past performance.

- Ensure insurance coverage of self, materials and people working on site. (Once work allotted).
